Fund Profile

The fund is a directionally biased Long / Short equity fund which will not hesitate to capture equity market beta when conditions allow for it. The objective of the fund is to generate the largest portion of its returns through its directional bias, in so doing capturing 60% of the upside return of the market, while protecting against 60% of the downside. Relative value pairs, together with absolute longs and shorts seek to stabilise returns in turbulent market conditions, supported by the adjustment to the net exposure. Leverage is on average at 2.5 times and net exposure will vary with the fund manager's view of the market.

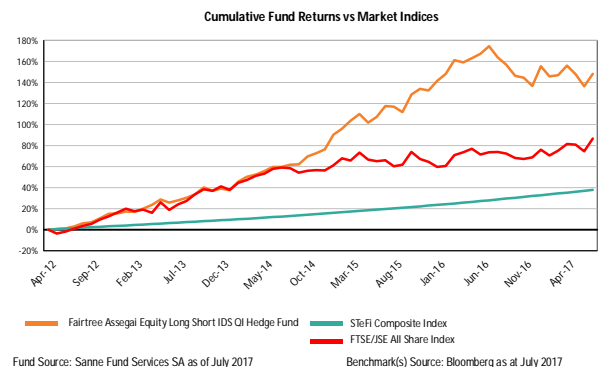

Objective/Investment Policy and Mandate

The long-term objective of the portfolio is to achieve consistent absolute returns through investment in long/short equity based strategies. The portfolio may use leverage to a maximum of 3.5 times the net asset value of the portfolio. Excluded from this calculation shall be the investments in the portfolio solely used to enhance the interest earned by the portfolio.

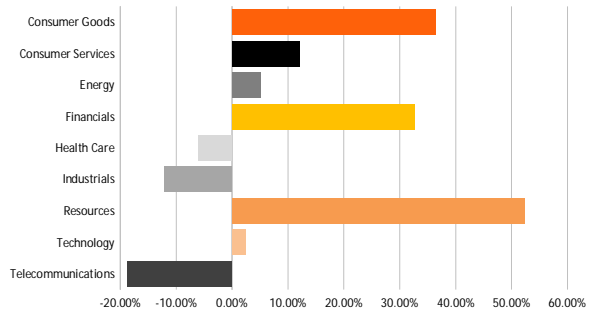
Limits and Constraints:

- The portfolio is precluded from raising any debt funding over and above that achieved in terms of the long/short process;
- No net individual equity position shall exceed 15% of capital;
- Directional exposure limit to 120% of current underlying capital on the long side and up to 20% of current underlying capital on the short side;
- The portfolio shall at all times hold a minimum of 10 equity positions; and
- The portfolio will limit exposure to equities based upon liquidity.

Portfolio Valuation & Transaction Cut-Off

Portfolios are valued monthly. The cut off time for processing investment subscription is 10:00am on the last day of the month prior to enable processing for investment on the first day of the next month.

Total Expense Ratio

Market Commentary

MSCI SA (+6.8%) outperformed MSCI EM (+6.0%) in July in dollars, despite a weak rand (-0.85%). The FTSE/JSE ALSI hit a new record of 55,207.4 on 31 July, 2017, driven by positive news flow both on the global front - dovish central bank commentary, and the local front - a surprise SARB rate-cut. The SARB lowered the repo rate 25bps to 6.75% based on lower inflation and GDP forecasts. The SARB now forecasts inflation to average 5.3% in 2017, 4.9% in 2018 and 5.2% in 2019, while they forecast SA GDP growth at 0.5% this year and 1.2% in 2018. The ANC policy conference suggested that Deputy President Ramaphosa appears to be gaining ground in the succession race for ANC party presidency in Dec'17. However, opposition parties expect President Zuma to survive the vote of no confidence, scheduled for August 8.

YTD, SA equities recorded outflows of \$3.4bn, significantly lagging inflows into EM equities of \$49.2bn ytd. However, SA bonds appear to be receiving close to their fair share of inflows, with SA bonds recording inflows of \$3.8bn ytd, vs. cumulative inflows into EM bonds of \$68.5bn ytd. However, in July, SA equities saw a turnaround in sentiment with inflows of \$0.7bn, while SA bonds saw inflows of \$0.8bn. Dissecting the flows, it appears that SA dual-listed stocks account for at least ~75% of the equity outflows out of SA ytd. Ex-dual-listed, SA equities saw inflows of \$1.1bn in July.

The major contributions to MSCI SA's return of 6.8%, included Naspers (+12.7%) as the rally in Tencent continued. Interest-rate sensitive sectors, including MSCI SA Banks (+8.1%) and MSCI SA Retail (+7.1%) rallied, driven by a surprise SARB rate-cut. MSCI SA Materials (+11.1%) bounced back, as metals and oil rallied in July. Of the sectors that slid into the red, MSCI SA Healthcare (-3.9%) suffered the most, followed by MSCI SA Consumer Durables (Steinhoff), down -2.2%.

July was a good month for commodity prices, with the LME Metals Index up 4.4%. Nickel (+8.8%) recorded the largest monthly gain followed by Copper (+6.9%), Tin (+2.8%), Lead (+1.5) and Zinc (+1.2%). Only Aluminium ended the month down 0.9%. Brent and WTI jumped 7.5% and 8.4% to US\$52.72/bbl and \$50.17/bbl, respectively. A combination of factors including a weaker US Dollar, optimism around OPEC production cuts, and declining US oil inventories contributed to the rise. Iron ore surged 13.5% in July to US\$73.7/t amid strong China data. Gold rose 2.2% to \$1269.4/oz, supported by a weak Greenback.

The fund maintains a large exposure to the resource sector, since we believe that the current strength in global macro conditions support robust commodity prices, and the mining equities are presently generating significant cash and present great value to investors. Two of the fund's largest exposures are Kumba Iron Ore and Anglo American. Both these stocks surprised the market this month when they reported good results and resumed dividend payments. Anglo American was up 21.8% (in dollars) and Kumba 13.2% during July.

During the month we cut the net short position in the retail sector as we were concerned that the SARB could surprise the market with a rate cut. We are now net long the sector, with exposure to the quality names which are outperforming in this challenging economic environment. The fund remains long the banks, but since the rate cut we have trimmed positions in FirstRand (+8.5%) and Standard Bank(+12.1%) , which we believe have run too hard. We continue to see value in the long term insurers, which are underpinned by solid fundamentals and attractive valuations.

Glossary

- NAV:** The net asset value represents the assets of a Fund less its liabilities.
- Alpha:** Denoted the outperformance of the Fund over the benchmark.
- Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- Sortino Ratio:** the Sortino Ratio is used to measure the risk-adjusted return of the fund.
- Standard Deviation:** The deviation of the return stream relative to its own average.
- Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.
- Max Gain:** Largest increase in any single month.
- % Positive Month:** The percentage of months since inception where the Fund has delivered positive return.
- Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.
- Average Credit quality:** The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
- Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.
