Fund Profile & Investment Policy

The fund is a directionally biased Long / Short equity fund which will not hesitate to capture equity market beta when conditions allow for it.

Investment Strategy

The portfolio is managed as a long/short hedge fund, focused on extracting alpha returns from the South African equity market. The fund's returns are delivered through fundamental knowledge of South African equities vis-à-vis economic growth and broad economic themes as well as medium to long-term relative valuation opportunities, generating the largest portion of its returns through its directional bias. Relative value pairs, together with absolute longs and shorts seek to stabilize returns in turbulent market conditions, supported by the adjustment to the net exposure.

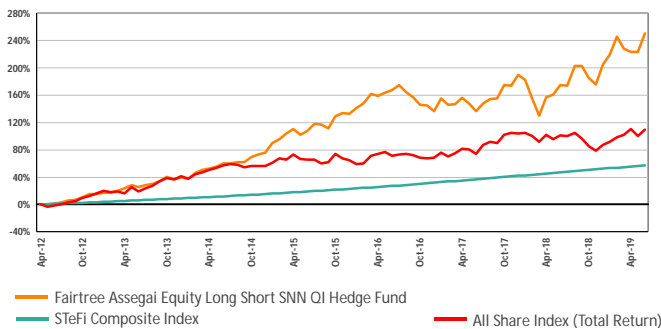
Investment Mandate

The portfolio may use leverage to a maximum of 4.5 times the net asset value of the portfolio. However, the portfolio has set an internal limit to use leverage up to a maximum of 3.5 times the net asset value. Excluded from this calculation shall be the investments in the portfolio solely used to enhance the interest earned by the portfolio.

Mandate limits and constraints:

- The portfolio is precluded from raising any debt funding over and above that achieved in terms of the long/short process;
- No net individual equity position shall exceed 15% of capital;
- Directional exposure limit to 120% of current underlying capital on the long side and up to 20% of current underlying capital on the short side;
- The portfolio shall at all times hold a minimum of 10 equity positions; and
- The portfolio will limit exposure to equities based upon liquidity.

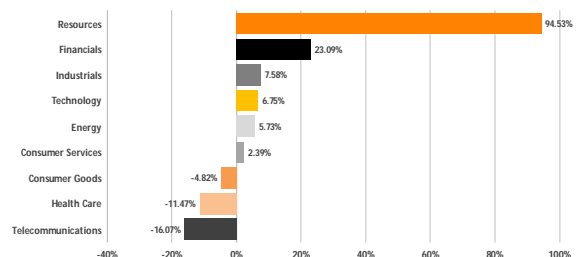

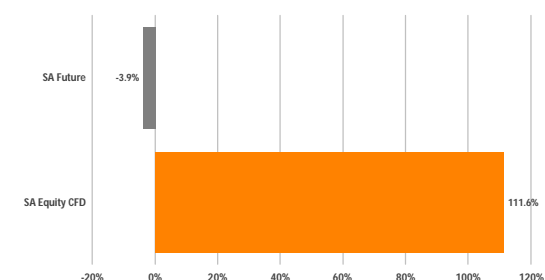
Portfolio Objective

Fee Classes

Total Expense Ratio

Market Commentary

The All Share rose 4.8% during June, with stocks outperforming bonds (ALBI +2.3%) and cash (STEFI +0.5%). In dollar terms MSCI SA rose 6.3% in the month, slightly ahead of MSCI EM (+6.2%) but behind MSCI World (+6.6%). Global equities rebounded as the US-China trade war ebbed. The G-20 summit saw Trump back off some threats - saying he would hold off raising tariffs on an additional US\$300bn in Chinese imports and would allow US firms to do business with Huawei. Trump also claimed that China would import more American farm production, but Chinese official media did not say that was part of any agreement. Global growth data remained negative with further declines in PMIs. The 19 June FOMC meeting saw no rate change, but a strong statement virtually promising a cut at the 31 July meeting. Global bond yields continued to rally with US 10 year yields down 12bps to 2.01%. US 10 years are down >125bps since November. The rand strengthened 3.5% versus the US dollar, benefiting along with other emerging market currencies as investors searched for yield. Commodities ignored falling yields, with the LME Metals Index up 2.01%, while Brent crude rose US\$1.5 to US\$64.43/bbl.

In the local market, Resources equities outperformed strongly (+10.2%), with precious metals and iron ore the key drivers. Industrial stocks also ended in the black (+3.8%), with Financials the laggards (+1.3%). Gold stocks lead performance (+24.5%), as did Platinum counters (+14.8%) and Miners (+13%); while Chemicals (-4.5%) and Industrials (-4.1%) underperformed.

Weak economic data dominated the post-election headlines in South Africa with 1Q GDP falling 3.2% quarter on quarter, worse than the -1.6% Bloomberg consensus expectation. In a significant swing, the FRA s appear to be pricing in 40bp of rate cuts in South Africa in the next 12 months. The SA ABSA PMI averaged 46.3 in 2Q19 (below 1Q19), given weak demand. The SA PMI business activity and new sales orders remained below 50 index points for five consecutive months to June, and the SA PMI employment index recorded its worst quarter in 2Q19 since 2009. The President's State of the Nation speech promised little more than further Eskom bailouts and progress on spectrum auctions, with few concrete details or deadlines. Ace Magashule, the ANC Secretary General, called for a wider mandate for the SARB and for a "quantity easing" policy, one example of the increasing factionalism within the ruling party.

The Assegai fund rose 8.5% in June. Long positions in gold equities contributed significantly to the strong performance - with AngloGold (+3%), Harmony (+2.5%), Sibanye Stillwater (+1.4%) the largest contributors. Long positions in the diversified miners also contributed positively, with Anglo American adding 1.2% and BHP Billiton a further 1%. KAP fell sharply after warning of lower profits, our long position in the stock detracted 0.8% during June. Other detractors were the short positions in Brait (-0.8%), Multichoice (-0.4%) and Telkom (-0.4%).

We cut the resource sector exposure slightly during June, although this remains a very large overweight in the fund. Exposure to the financial sector increased, as we took profits on a short position. The net long position in industrials moved to a net short, although we decreased the net short position in the retail sector.
