

## Fairtree Assegai Equity Long Short SNN QI Hedge Fund

### Fund Profile & Investment Policy

The fund is a directionally biased Long / Short equity fund which will not hesitate to capture equity market beta when conditions allow for it.

### Investment Strategy

The portfolio is managed as a long/short hedge fund, focused on extracting alpha returns from the South African equity market. The fund's returns are delivered through fundamental knowledge of South African equities vis-à-vis economic growth and broad economic themes as well as medium to long-term relative valuation opportunities, generating the largest portion of its returns through its directional bias. Relative value pairs, together with absolute longs and shorts seek to stabilize returns in turbulent market conditions, supported by the adjustment to the net exposure.

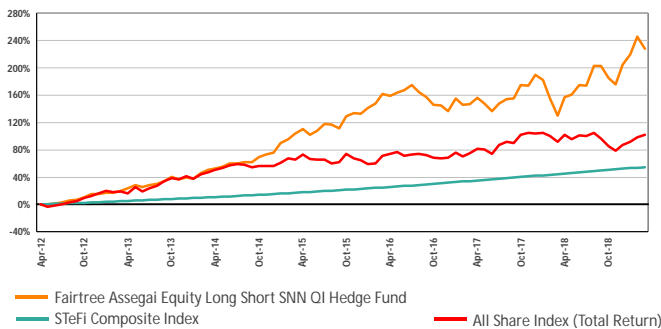
### Investment Mandate

The portfolio may use leverage to a maximum of 4.5 times the net asset value of the portfolio. However, the portfolio has set an internal limit to use leverage up to a maximum of 3.5 times the net asset value. Excluded from this calculation shall be the investments in the portfolio solely used to enhance the interest earned by the portfolio.

#### Mandate limits and constraints:

- The portfolio is precluded from raising any debt funding over and above that achieved in terms of the long/short process;
- No net individual equity position shall exceed 15% of capital;
- Directional exposure limit to 120% of current underlying capital on the long side and up to 20% of current underlying capital on the short side;
- The portfolio shall at all times hold a minimum of 10 equity positions; and
- The portfolio will limit exposure to equities based upon liquidity.

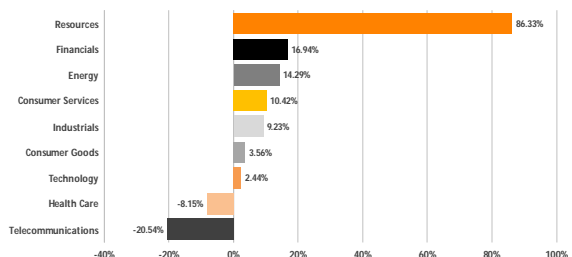

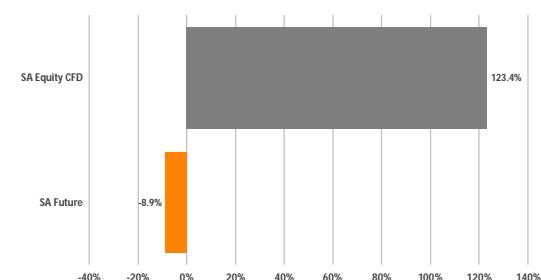
### Portfolio Objective

### Portfolio Valuation & Transaction Cut-Off

Portfolios are valued monthly. The cut off time for processing investment subscription is 10:00am on the last day of the month prior to enable processing for investment on the first day of the next month.

### Total Expense Ratio

### Market Commentary

The All Share rose 1.6% in Rands during March, but rand weakness (2.9% versus the dollar to 14.50) meant the local index underperformed MSCI World (+1.3%) and MSCI EM (+0.8%) in dollars. Bonds tracked the global bond rally with R186 yields -12 bps to 8.60% and the ALBI index +1.3% in the month. Resources (+3.1%) outperformed Industrials (+2.9%) and Financials (-4%). By sector, Tobacco (+18.7%), Industrial Metals (+19.2%) Media (+14.9%), Beverages (+10%) and Tech (+9.3%) were the key winners, while General Industrials (-5.9%), Banks (-6.0%), Healthcare (-14.1%) and Pharma (-31.1%) were the key laggards.

Eskom stayed in the headlines as Stage 4 load-shedding hit the country in the middle of March, although the load shedding had abated by month end. Electricity supply shortages caused by unplanned maintenance were exacerbated by cyclone Idai in Mozambique. NERSA agreed headline electricity hikes of 8.4% for 2019, but Eskom is allowed to recover some costs of previous years, leading to a 13.8% tariff hike. The SARB left rates unchanged at its 28 March meeting and cut its 2019 GDP forecast from 1.9% to 1.3%. The SARB also revised core inflation expectations for 2019 lower (4.8% vs 5% previously). Moody's did not change South Africa's Investment Grade rating this month, instead deferring its scheduled review.

In March, SA equities had net foreign outflows of USD 0.80 bn whereas SA bonds had a net outflow of USD 0.24 bn. Meanwhile, cumulative inflows to EM bonds and equities YTD are now \$34.7 bn and \$22.8 bn, respectively. Standard Bank and Kumba Iron Ore were the most bought stocks and Multichoice and AB InBev were the most sold stocks by foreigners in March.

The Assegai fund fell 5.19% during March. Long positions in resources added positively to performance, especially Northam Platinum (+1.2%), Kumba Iron Ore (+0.8%) and Sasol (+0.4%). A short position in Brait also contributed positively (+1%), as did long positions in Naspers (+0.8%) and Anheuser-Busch (+0.7%). The short position in British American Tobacco detracted most from performance in March (-2.1%) as did long positions in Fortress B and EOH, and a short position in Multichoice Group.

Resource exposure increased during March, as stocks outperformed. Exposure to the banking and financial sectors was increased further, while retail sector exposure was cut. The fund remains underweight telco's, and is now also underweight the healthcare sector.
