

FUND PROFILE

The Fairtree Balanced Prescient Fund is an actively managed multi asset class fund. The fund is suitable for investors looking for moderate to high capital growth in excess of inflation with moderate to aggressive risk appetite. It suits investors with an investment horizon of more than 3 years and who prefer to have the asset allocation decision made for them. The fund complies with Regulation 28 and is therefore suitable for retirement savings.

FUND OBJECTIVE

The Fairtree Balanced Prescient Fund aims to generate long-term wealth for investors by producing inflation beating returns. The fund is managed against a composite benchmark that also forms the strategic asset allocation for the fund.

INVESTMENT POLICY


The fund invests in a diverse combination of equities, property, bonds and money market instruments. The portfolio has a long-term focus and invests predominately in domestic securities whilst up to 25% of the fund may be invested in foreign securities.

The fund is actively managed, both at security and asset class level to create capital growth while preserving capital on a real (above inflation) and absolute basis.


HISTORICAL PERFORMANCE SINCE INCEPTION


RISK PROFILE



Risk Level: Moderate - Aggressive

These portfolios generally hold more equity exposure than low risk portfolios but less than high risk portfolios. In turn the expected volatility is higher than the low risk portfolios but less than high risk portfolios. The probability of losses are higher than that of the low risk portfolios, but less than high risk portfolios. Expected potential long term investment returns could therefore be lower than high risk portfolios due to lower equity exposure, but higher than low risk portfolios.

GLOSSARY

Annualised performance	Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

NAV	The net asset value represents the assets of a Fund less its liabilities.

Total Investment Charges (TIC%) = (TER % + TC)	The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

MARKET COMMENTARY

The backdrop for emerging market assets remains healthy, supported by low market volatility, accommodative monetary policy and lower than expected inflation prints. The weakening US dollar is also supporting emerging market assets. We continue to view the market's assessment of risk as too complacent. The potential for higher global bond yields and less accommodative monetary and fiscal policies may weigh on future returns. Stronger economic data and rising inflation in Europe, US and China may allow their central banks to become less accommodative over the next few months.

The Central Bank of Canada hiked rates by 0.25% last month and the Bank of England and Reserve Bank of Australia are debating potential rate increases over the medium term. We expect the US Fed and European Central Bank to announce steps towards balance sheet normalisation during their September and October meetings. We believe the Fed will only hike rates again in December, and that it will continue to hike three to four times during 2018.

The surprise 0.25% rate cut by South African Reserve Bank came after they revised down the growth and inflation outlook. The economy is now only expected to grow at 0.5% in 2017 while inflation is expected to bottom at 4.6% early in the first quarter of 2018. The rate cut came one meeting earlier than we expected, but given the weak growth outlook, lower inflation and stronger Rand we see agree with the SARB's action and believe they will cut rates again this year, potentially at their next meeting. The rate cut will alleviate some pressure facing consumers, but will not alter the current weak growth momentum. Consumer and business confidence remain weak along with credit growth and retail sales. However, the second quarter's growth number should show a marked improvement, mainly due to a low base from the first quarter and driven by agriculture, net exports and consumption.

Deteriorating growth and fiscal dynamics has increased the risk of further local debt ratings downgrades to sub investment grade by year end. South Africa faces exclusion from Citi's World Government Bond Index (WGBI) once both S&P and Moody's have downgraded South Africa to sub investment grade.

On the global front economic data continued to improve at a gradual pace. Forward looking US, China and EU data remain strong while the US and EU labour markets continue to improve. Second quarter GDP growth numbers indicate that the major economic regions are growing above trend; US 2.6%, Europe 2.4%, China 7%. We are also encouraged by signs that global trade has strengthened.

Despite the improving growth backdrop markets remain cautious about the outlook given the political and policy uncertainty caused by the Trump Administration. Potential military action against North Korea, Russian sanctions, Chinese trade investigations and the failure to pass a new Healthcare Bill has weakened to US dollar against the Euro and EM currencies.

Equities: The outlook for global earnings growth remains strong supported by the gradual economic recovery. We expect global inflation to pick up over the medium term supported by easy financial conditions and looser fiscal policies. The global deflationary outlook created positive sentiment around cyclical and value orientated stocks, while the outlook for higher global bond yields will put pressure on high valuation defensive names. We believe the overall South Africa equity index will follow global equity markets higher due to its externalised nature. We remain cautious on domestic equities although we believe that economic activity will improve over the next 18 months. We will be more constructive once we have more political certainty. We favour global cyclical companies with global earnings growth potential and companies with the ability to generate cash sustainably.

Fixed Income: South Africa's inflation will improve over the next 12 months as food prices fall, the currency remains on strong footing and growth remains weak. The SARB has started to cut interest rates and will continue with at least one more cut later this year. However, political risks and risks of further credit downgrades over the medium term should keep the SARB relatively cautious. The focus on the search for yield by global investors and potential for a reduction in the political risk premium may support lower bond yields, however in the short term we remain cautious.

Currency: We believe the US dollar will trade stronger from current levels. The ECB will take a gradual approach in reducing asset purchases. We see the Rand at close to fair value, but see risks for some depreciation. Softer commodities and stronger US dollar will be balanced by an improving trade balance which should continue to support the Rand. Domestic political risk and a global policy mistake remain the key risks for the currency.

Alternatives: The global driver of growth is slowly shifting from easy monetary policy to easier fiscal policies, and combined with the outlook for higher interest rates has resulted in lower correlations amongst key macro variables. Market rotation and increased dispersion amongst asset classes and sectors has led to a more favourable environment for alternative assets to perform.
