INVESTMENT POLICY

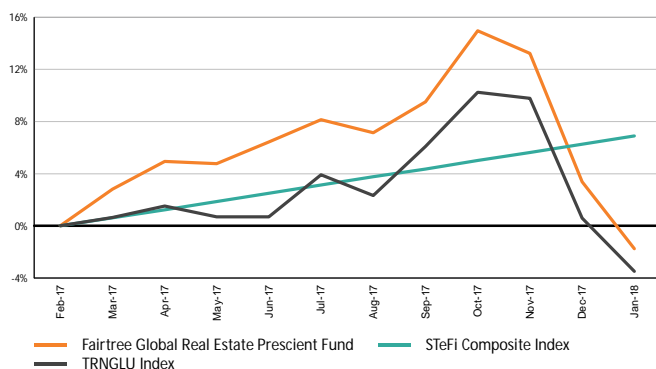
The portfolio has a long term focus, and is well diversified across geographic regions, currencies, real estate sectors and stocks. We will combine our top-down fundamental property market research with rigorous statistical valuation analysis using our proprietary models. We aim to lower portfolio volatility by adjusting the stocks and cash levels actively, while still outperforming our benchmark. We practice active risk management on a portfolio, sector and stock basis including the dynamic use of targets and stops. The fund will invest primarily in real estate equities in the United States, Japan, Hong Kong, Singapore, Australia, Europe and the UK.

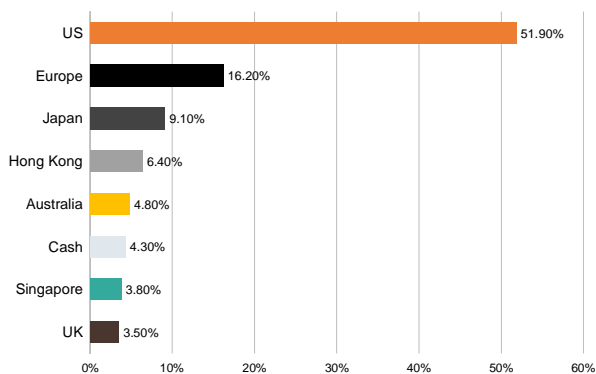

CUMULATIVE FUND RETURNS

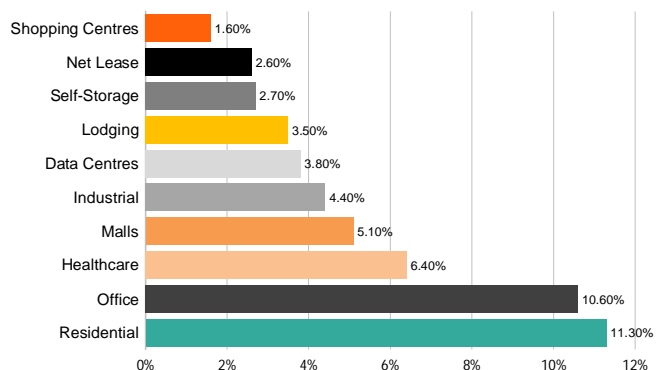
Cumulative Fund Returns vs Market Indices

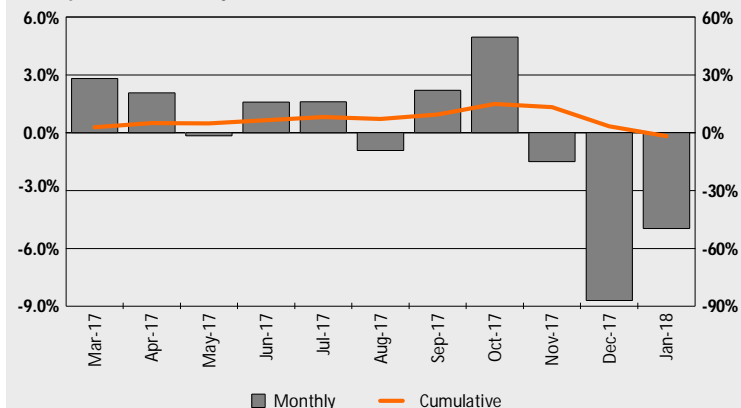

MARKET COMMENTARY

The fund was down 113bps in USD for the month, underperforming our index* by 119bps, primarily on the back of the month-end performance timing issue. This is worth explaining once for future reference. Prescient takes our performance as of 3pm SA time on the last day of the month and uses that for the full day, but over half our portfolio is in US stocks which have not even started trading yet. They then use the index for the full day after the US has closed for the benchmark, so if like this month the US stocks rise substantially on the last day of the month, the index is higher and our relative performance appears worse than it actually is because our US stock performance is not taken into account. Excluding that timing issue, we performed in line with the index at around flat for January in USD, and we should get a relative bump up in reported performance in February.

Our performance was substantially enhanced by our two Japan developers, Mitsubishi Estate and Mitsui Fudosan, which were both up around 10% during January. We retain an overweight position in this sector because it is one of the few places where one can find attractively valued property stocks globally, given they are still trading at over 1 STD below the mean on several metrics, including a discount to NAV of 40-45%. Fundamentally, the Tokyo office market is holding up well in face of new supply because of a starting point of very low vacancy rates. If this trend can continue in 2018, an ample supply year, then the stocks should rerate further. Rounding out the three top performers is CK Asset Holdings, the Hong Kong property company. We have reduced our portfolio weighting in this stock on the back of valuations getting fuller on the back of the stock price having risen 29% since we bought it 9 months ago.

The largest detractors to performance are all from the US. This is in line with our expectations because the US is more late cycle than the other geographies, with interest rates higher and moving up faster than other regions. Federal Realty, which is our only shopping centre stock with an underweight weighting for the sector, fell 9% over the month as the market got concerned with increased retail bankruptcies and store closures likely to be announced in the coming months. We remain underweight the sector. Similarly, Simon Property Group, the US mall operator, also had a tough January, falling 5%. It is our only retail mall stock in the US and we are underweight the sector. Ventas, the US healthcare stock, fell 7% to round out the top 3 losers. We have sold out of that position to change our Healthcare sector weighting to underweight, as rising rates are likely to continue to negatively affect the interest rate sensitive triple net part of their portfolios.

Looking forward, we remain overweight in Europe and the Japan developers, and underweight the US and Australia. European economic data remains strong, while inflation remains contained, while in the US there is increased likelihood of more rate rises given the tight labour market, tax cuts and potential fiscal stimulus. Within the US we are overweight residential, industrial and data centres, and underweight retail, healthcare and self-storage. Australian REITs are late cycle hence our underweight, and we have positioned ourselves in Goodman Group, an Australian listed global logistics specialist, which we believe is well positioned to benefit from strong secular global demand.
