The Fairtree Global Real Estate Prescient Fund objective is to provide our clients access to high quality, international real estate assets that should benefit from capital appreciation while also delivering solid dividends in USD. We aim to outperform our index by analyzing the central economic and political drivers in the various geographies, identifying global property sector trends and studying the specific physical property market and equity fundamentals.

INVESTMENT POLICY

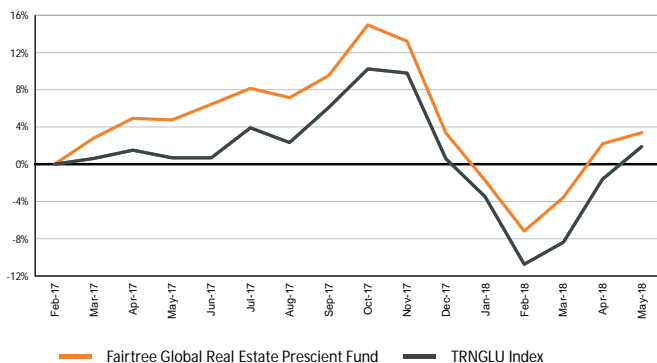
The portfolio has a long term focus, and is well diversified across geographic regions, currencies, real estate sectors and stocks. We will combine our top-down fundamental property market research with rigorous statistical valuation analysis using our proprietary models. We aim to lower portfolio volatility by adjusting the stocks and cash levels actively, while still outperforming our benchmark. We practice active risk management on a portfolio, sector and stock basis including the dynamic use of targets and stops. The fund will invest primarily in real estate equities in the United States, Japan, Hong Kong, Singapore, Australia, Europe and the UK.

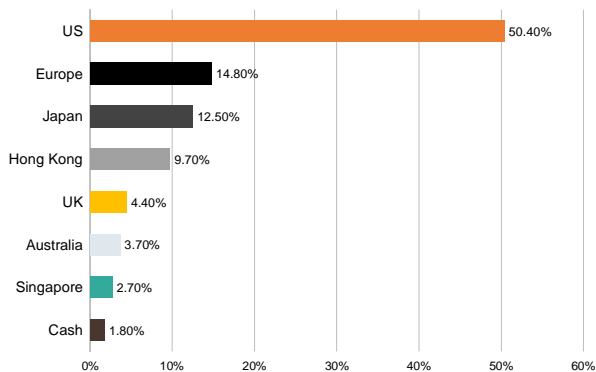

CUMULATIVE FUND RETURNS

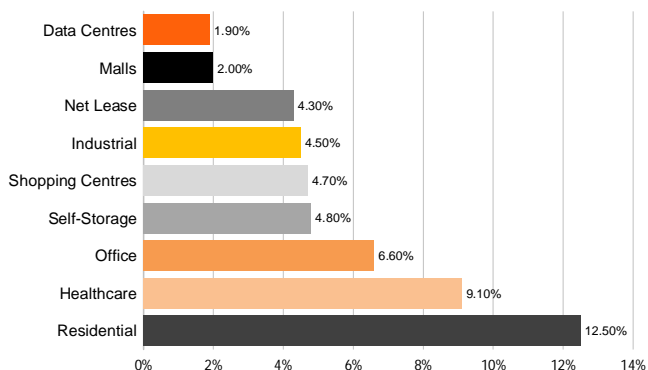
Cumulative Fund Returns vs Market Indices

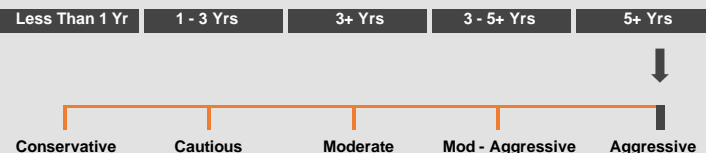

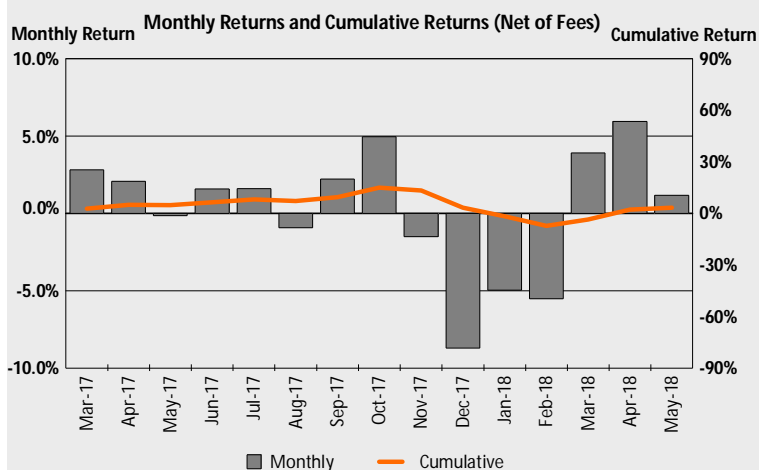

MARKET COMMENTARY

The fund was down 15bps in May in USD, underperforming our index* by 180bps. This is our worst month ever, driven by a confluence of factors reversing the fortunes of many of our long-held positions. Our overweight's in Singapore and Europe turned strongly against us, Singapore due to the retracement of one-sided positioning, and Europe due to Italian and Spanish political issues. In the US, our long-held overweight in datacentres went against us as the market was underwhelmed with the 1Q18 results out of Equinix.

During May, our strongest positive contributor was Welltower which rose 7%. The stock is coming off a low base, having underperformed the market for over a year. Valuations are attractive, and we are getting closer to the end of the oversupply situation in senior housing. Extra Space Storage rose 6.5% as the market is becoming more comfortable that the oversupply situation in 2018 is manageable and that 2019 should start to see a recovery in SS NOI growth. MGM Growth Properties rose 5.5% as investors looked favourably on triple nets as interest rates fell towards the end of the month, and this stock avoids the retail risks associated with many of the other stocks in this sector.

The largest detractors to performance were an eclectic group of stocks for a variety of different reasons. City Developments fell 12% on no news as investors decided to take profit after a sterling performance over the last 12 months. Colonial fell 8% as concerns over elections rattled Italy and Spain, the latter where half of the company's assets reside. Equinix fell 5% after revenue guidance was marginally trimmed in 1Q18 results, due to tenant churn in a portfolio of acquired assets. All three of these stocks hit our stops, and we immediately cut the position sizes in half, and any further falls in the share prices will be met with selling out of the positions entirely.

Looking forward, we remain overweight in Europe and view the current market weakness as a good entry point. We are also overweight the Japan developers, where valuations are attractive and the economy and corporates are doing well. We are underweight the US and Australia, both of which are fairly far along the property and economic cycle with rising rates and peaking GDP growth. Within the US we are overweight residential, healthcare and self-storage, and underweight malls, office and hotels.
