INVESTMENT OBJECTIVE & POLICY

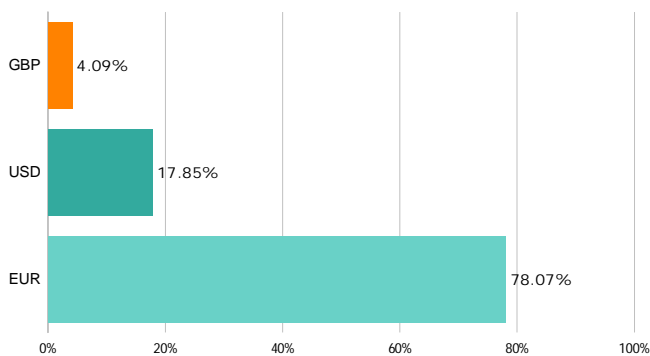

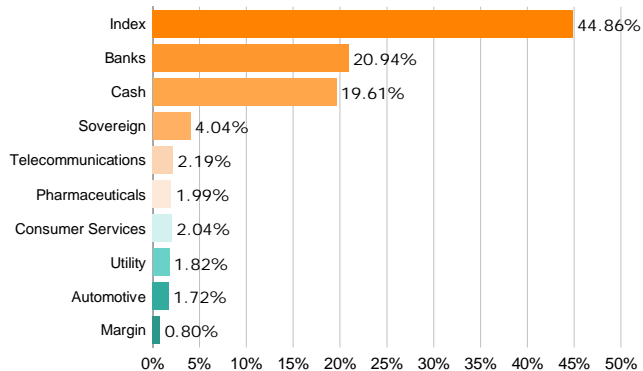

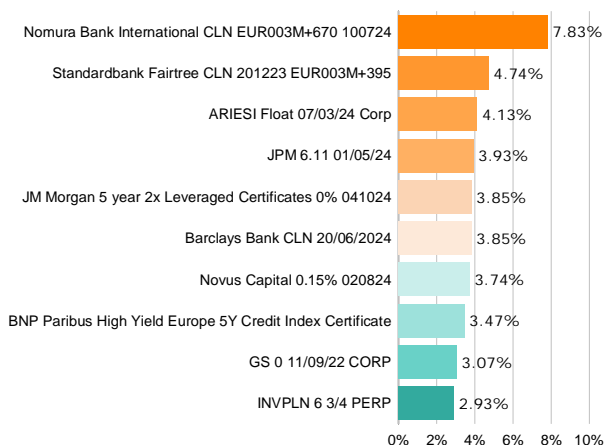
FX ALLOCATION (%)

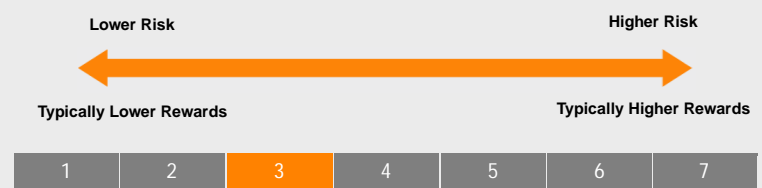

MARKET COMMENTARY

After a fantastic start to the month, credit markets collapsed upon the final realisation that consumer demand is quite curtailed if consumers become physically ill. The iTraxx XOver index, after pluming lows of 212 basis points (bps) mid-month, sold off to reach a closing high of 298 bps on the 28th, thus ending the month at spread levels last seen at the end of May 2019. The sell-off in spread terms was the 14th worst monthly sell off in basis points since March 2007 and the 8th worst month in percentage terms.

The investable index delivered -3.22% in total return during the month which, although a shocking absolute number, pales into insignificance when one considers the near meltdown experienced in other global risk markets. One could argue it either way, is this a once in 5 year buying opportunity, or is it merely the start of much worse things to come? Unfortunately only time will tell, and for those already fully invested the next couple of weeks may seem like a couple of years.

The Fairtree Global Flexible Income Plus Fund delivered a respectable performance of -2.08%, outperforming the benchmark by some 1.14%. The fund remains overweight cash but is cognizant of the potential global risks.

SPECIFIC RISK
