INVESTMENT OBJECTIVE & POLICY

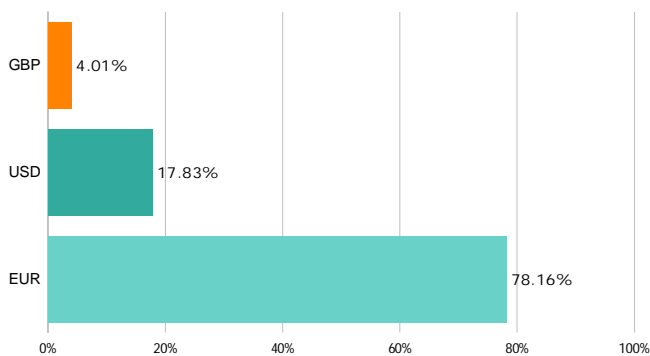

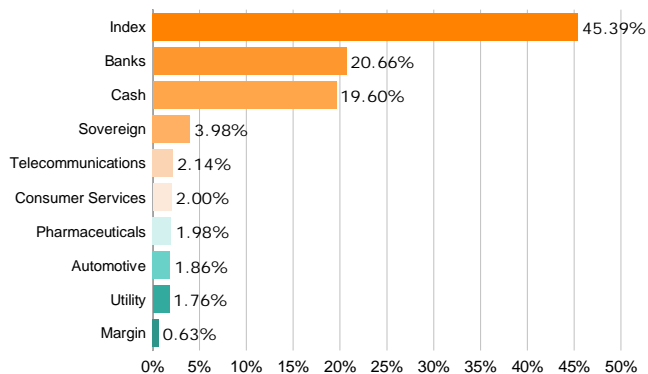

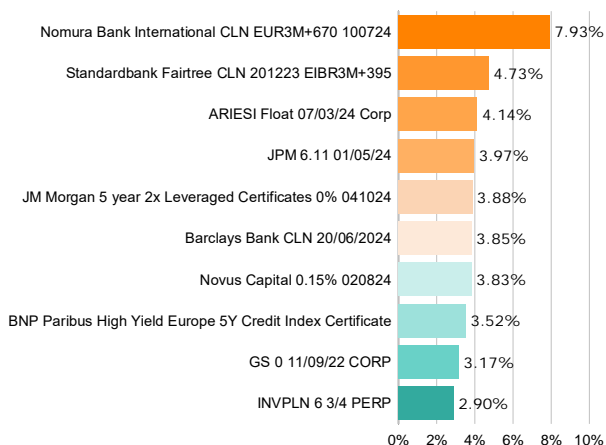
FX ALLOCATION (%)

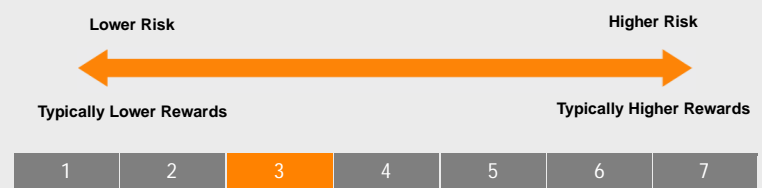

MARKET COMMENTARY

After a fantastic previous calendar year, 2020 got off to shaky start with global risk markets buckling upon news of the outbreak of the deadly Coronavirus emanating from China.

Global credit was not insulated from the global risk sell off with our benchmark iTraxx XOver index losing 1.00% over the month. The spread to EUIBOR, the tradable non-funded equivalent sold off from 206 basis points (bps) to end the month at its intra-month high of 230 bps.

The fund weathered the storm rather well only losing 0.44% during the period, thanks mainly to off benchmark positions as well as a healthy oversized cash position brought about by the maturity of a sovereign index linked investment.

Looking to February, the managers will look to pick up some investments into any sell off.

SPECIFIC RISK

Sharpe Ratio	The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
