INVESTMENT OBJECTIVE & POLICY

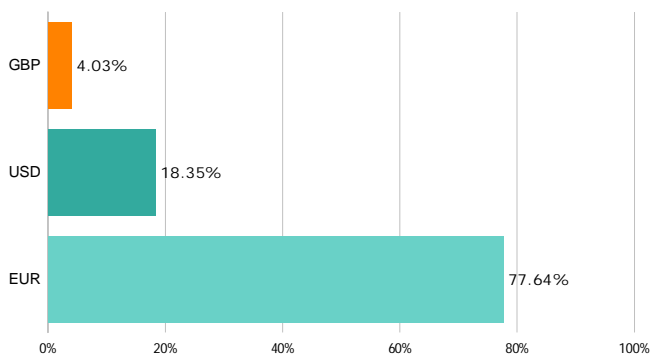

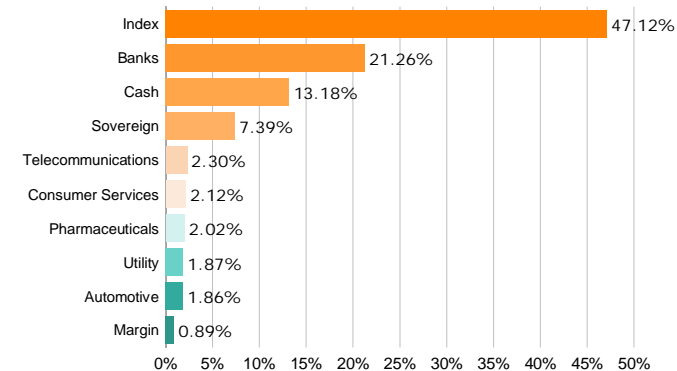

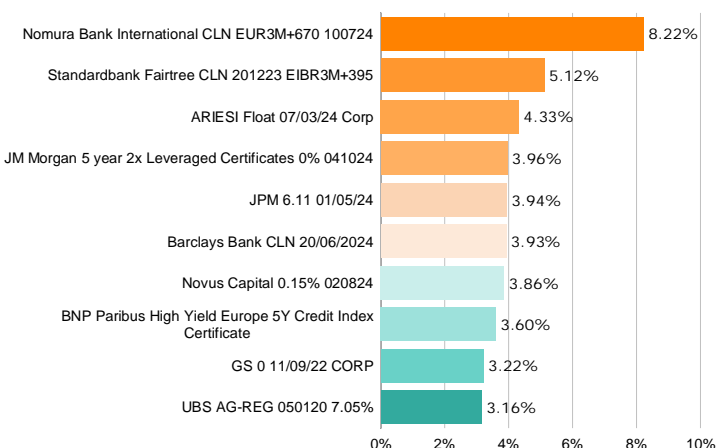
FX ALLOCATION (%)

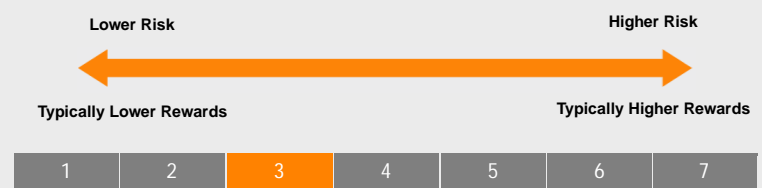

MARKET COMMENTARY

It wasn't a particularly great month for European credit, with our benchmark iTraxx Crossover 5 year Total Return Index underperforming absolutely as well as relatively speaking from a risk adjusted perspective. The iTraxx Crossover 5 year Total Return Index delivered a rather flaccid -0.23% which at the end of the day is neither here nor there. The numbers look particularly bad when we move up the risk spectrum to European equities where we witnessed the large capitalisation index SX5E producing some 0.98% during the month. North American equities continued their surge with the S&P 500 producing a saliva inducing 2.17% in total return. The domination of equities over credit over the course of 2019 has been startling. The S&P500 has produced some 23.2% return so far this year whilst even the European Large Cap equivalent hasn't been that far behind at 20.1% in local currency. The laggards have been credit and government bonds, with German bunds bearing the brunt of the revaluation of the asset class. The German 5 year Bund index has produced some 1.51% on a year to date basis, but methinks negative nominal yields will continue to pummel risk adverse investors unless they are speculating that bund yields go more negative.

There was one credit default auction during the month, where the results of the Thomas Cook Group were published at 10.125%. In other words debt financiers are expected to receive some 10.125% of their original investment. That's not a particularly good outcome for those who believe that debt is fully backed by balance sheet assets. Perhaps this firm should have gone out of business quite some time ago - at least debt holders would have gotten more of their money back.

The Fairtree Global Flexible Income Plus Fund (A Class) produced a rather pleasing 0.79% over the month of October, outperforming the benchmark significantly. The outperformance was primarily driven by the exposure to North American High Yield as well as the various individual off benchmark positions within the fund.

SPECIFIC RISK
