FUND PROFILE

The Fairtree Select Equity Prescient Fund is a high conviction actively managed equity fund. The portfolio has a long-term focus invests in securities across all sectors of the JSE Securities Exchange which trade below intrinsic value or have capital appreciation potential. The portfolio will invest in offshore securities when the benefit of higher returns and portfolio diversification are available.

INVESTMENT OBJECTIVE

The objective of the Fairtree Select Equity Prescient Fund is to provide investors with medium to long term capital growth from a selection of high conviction, concentrated equity opportunities, predominantly within the South African market.

INVESTMENT POLICY

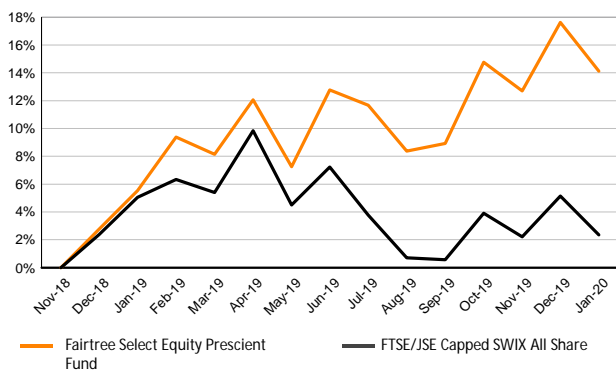
In order to achieve its objective, the portfolio will typically hold 25 shares. The fund is restricted to a maximum of 40 shares. The fund will invest across all industry sections ranging across large, mid and smaller cap shares.

Although the portfolio manager will predominantly investment in South African markets, the manager may also include investments in offshore jurisdictions.

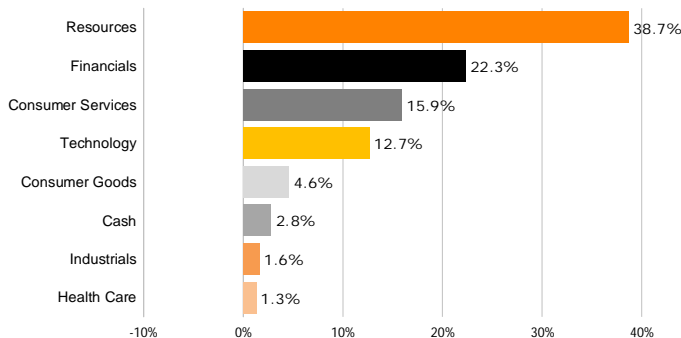

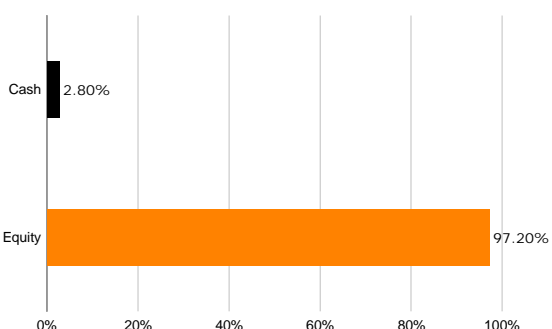
CUMULATIVE FUND RETURNS VS MARKET INDICES

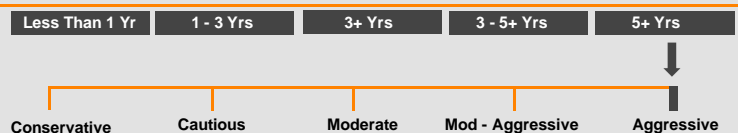

The combination of macro factors and a bottom-up fundamental research driven approach, helps us to identify exceptional investment cases that should deliver market beating performance. We actively manage risk and optimize return by managing position sizing. We continually reassess risks and potential returns in changing circumstances, ensuring appropriate portfolio changes to protect capital, while keeping a firm focus on longer term compounding of returns.

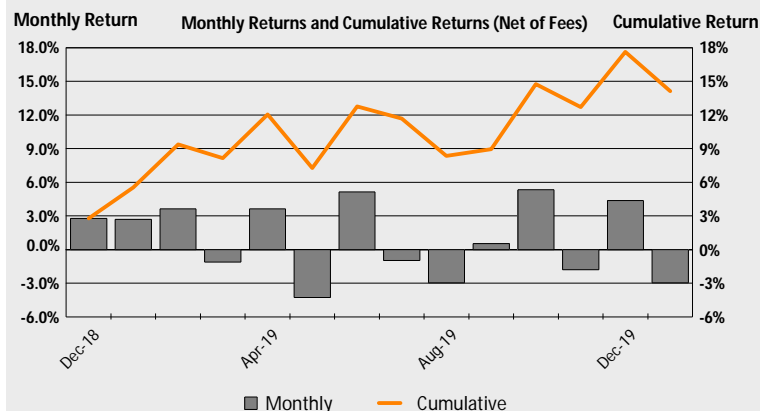

Market correlation

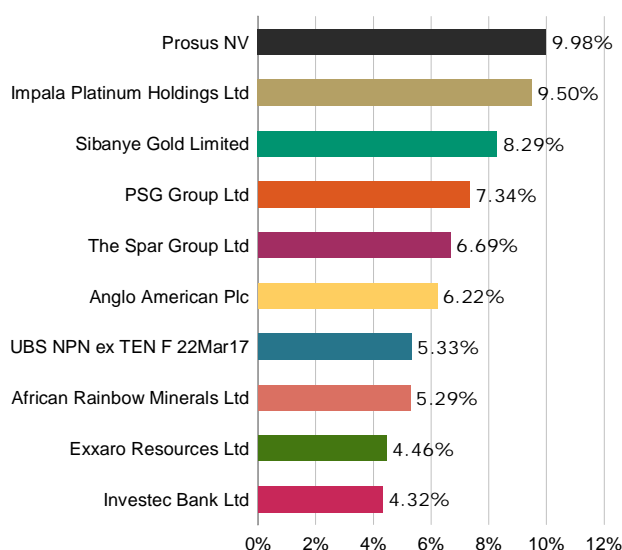

MARKET COMMENTARY

The fund delivered a pleasing start to the year amidst volatile markets. The South African retailers reported underwhelming sales reports over the festive period. While many counters have been discounting a deteriorating trend, we continue to prefer our defensive food retail exposure and have stayed out of the more cyclical exposure. Many domestic counters are trading at attractive valuations with stable balance sheets and strong dividend potential in an environment where growth is lacking.

The National Budget in late February will be a vital information point for our domestic view. We see scope for rate cuts and alleviating pressure on the consumer in the outlook, but a weakening budget deficit will hamper the SARB's ability to be accommodative in the case that the Rand weakens dramatically. Domestic facing cyclicals are trading on multi year low valuations and any improvement in our outlook would offer strong investment returns.

Global macro was plagued by uncertainty from Geopolitics and the possible threat that the Covid-19 virus poses. The fund holds material exposure towards China end-demand and many of our holdings will be impacted by a protracted global supply chain impact. Given the available information we will monitor developments closely, but have not made any dramatic changes to the portfolio.

We note that most of our commodity exposure continues to see supply shortages which have supported our estimation of possible capital returns. We have decreased our exposure in Richemont as many of the risks in the investment case are playing out. The fund has maintained its PGM exposure which will continue to drive relative performance given the volatility of the PGM sector. We continue to believe that our exposure offers good cash flow yields and attractive valuations despite strong price performance.

SPECIFIC RISK

Highest & Lowest return	The highest and lowest returns for any 1 year over the period since inception have been shown.
NAV	The net asset value represents the assets of a Fund less its liabilities.
Alpha	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio	The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
Sortino Ratio	The Sortino Ratio is used to measure the risk-adjusted return of the fund.
Standard Deviation	The deviation of the return stream relative to its own average.
Max Drawdown	The maximum peak to trough loss suffered by the Fund since inception.
Max Gain	Largest increase in any single month.
% Positive Month	The percentage of months since inception where the Fund has delivered positive return.
Average Duration	The weighted average duration of all the underlying interest bearing instruments in the Fund.
Average Credit quality	The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
Dividend Yield	The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.
PE Ratio	The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
High Water Mark	The highest level of performance achieved over a specified period.
Total Expense Ratio (TER%)	The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.
Performance fee incl. in TER (%) PF (%)	The Performance Fee is a payment made to the Fund Manager for generating positive returns, and is generally calculated as a percentage of investment profits, often both realized and unrealized.
Transactions Costs (TC%)	The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.
Total Investment Charges (TIC%) = TER (%) + TC (%)	The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
