FUND PROFILE

The Fairtree Select Equity Prescient Fund is a high conviction actively managed equity fund. The portfolio has a long-term focus invests in securities across all sectors of the JSE Securities Exchange which trade below intrinsic value or have capital appreciation potential. The portfolio will invest in offshore securities when the benefit of higher returns and portfolio diversification are available.

INVESTMENT OBJECTIVE

The objective of the Fairtree Select Equity Prescient Fund is to provide investors with medium to long term capital growth from a selection of high conviction, concentrated equity opportunities, predominantly within the South African market.

INVESTMENT POLICY

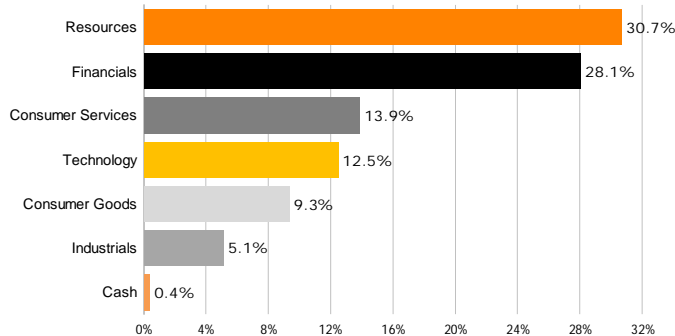
In order to achieve its objective, the portfolio will typically hold 25 shares. The fund is restricted to a maximum of 40 shares. The fund will invest across all industry sections ranging across large, mid and smaller cap shares.

Although the portfolio manager will predominantly investment in South African markets, the manager may also include investments in offshore jurisdictions.

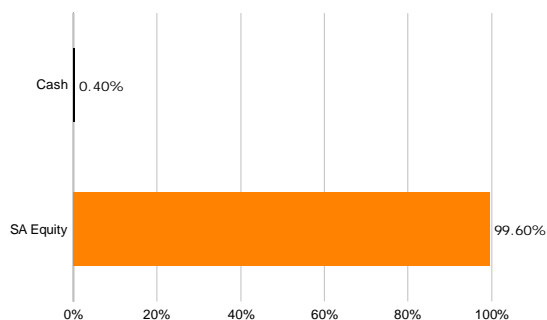

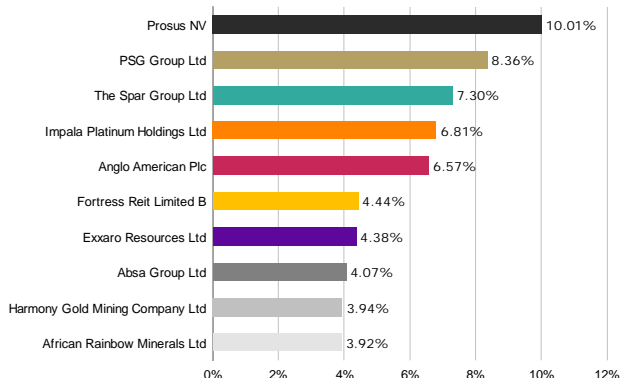
SECTOR ALLOCATION

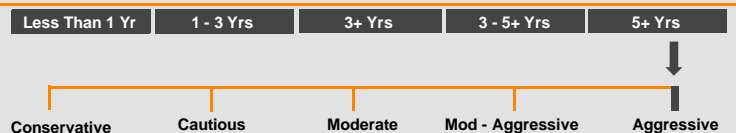

RISK PROFILE



Risk Level: Aggressive

The portfolio is a high conviction, concentrated portfolio of listed equities across all sectors of the JSE. The portfolio is comprised of our best bottom-up ideas, whilst balancing sector specific risks and macro influences. The combination of macro factors and a bottom-up fundamental research driven approach, helps us to identify exceptional investment cases that should deliver market beating performance. We actively manage risk and optimize return by managing position sizing. We continually reassess risks and potential returns in changing circumstances, ensuring appropriate portfolio changes to protect capital, while keeping a firm focus on longer term compounding of returns.

SPECIFIC RISK

- **Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
- **Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Highest & Lowest return	The highest and lowest returns for any 1 year over the period since inception have been shown.
NAV	The net asset value represents the assets of a Fund less its liabilities.
Alpha	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio	The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
Sortino Ratio	The Sortino Ratio is used to measure the risk-adjusted return of the fund.
Standard Deviation	The deviation of the return stream relative to its own average.
Max Drawdown	The maximum peak to trough loss suffered by the Fund since inception.
Max Gain	Largest increase in any single month.
% Positive Month	The percentage of months since inception where the Fund has delivered positive return.
Average Duration	The weighted average duration of all the underlying interest bearing instruments in the Fund.
Average Credit quality	The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).

MARKET COMMENTARY

November was another flat month for most local indices, with large divergence in performance from the various constituents. This fund delivered in line with most local indices, but the divergence created an nice opportunity for return generation into the calendar year end. Globally, the S&P 500 continued to post fresh highs, as fears of a recession are pushed out due to optimism around progress on a trade deal. Manufacturing PMI's in most developed markets and China also seemed to turn the corner spurring global risk taking in broader markets.

We saw interesting restructuring announcements by some of the major holding companies listed on the JSE. In an attempt to close the discounts to their respective sum-of-the-parts Remgro (+13.1%) announced that RMH will unbundle FirstRand and that they will do the same with their banking interests. This proved effective and we saw a rerating in both shares. The banking index came under pressure as Nedbank (-4.4%) and Standard Bank (-4.5%) gave pre-close updates that highlighted the tough economic conditions they need to navigate. The fund still carries very little exposure to the broader South African Banking counters. Since selling FirstRand, we have taken the view that the banking landscape is deteriorating and that we are likely to see pressure on the traditional dividend growth drivers.

Naspers (-2.4%) and Prosus (-4.8%) continued to tread water, despite Tencent (+3.4%) posting gains on the back of another quarterly result that showed +24% earnings growth. The market is unconvinced by the proposed JustEat deal. Prosus is hosting an investor day early in December, where they might be able to provide more colour on why they are so confident about this space. On balance, we believe the investment case has become more appealing after a sustained period of underperformance and the counters together remain our largest exposure.
