### INVESTMENT OBJECTIVE

The Fairtree Equity Prescient Fund is an actively managed domestic general equity fund with a focus on maximizing total returns for the client. The Fund aims to actively invest in equities with a level of capital appreciation and income potential and to outperform its benchmark, the FTSE/JSE Capped Shareholder Weighted All Share Total Return Index (CAPPED SWIX) over the long term.

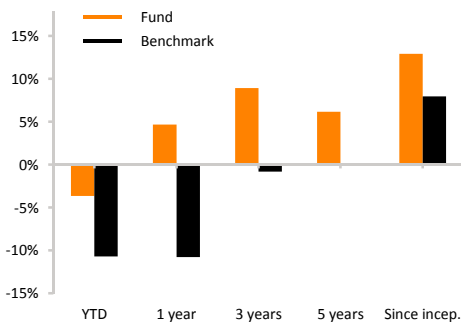
### INVESTMENT POLICY

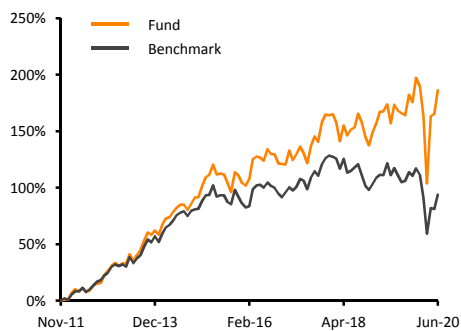
### RISK INDICATOR

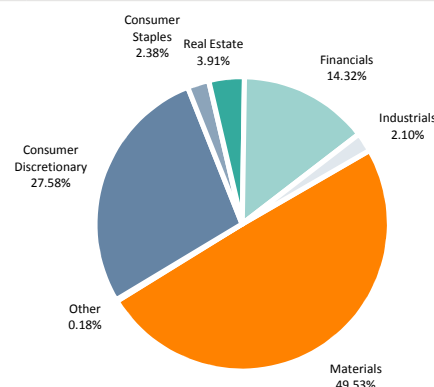

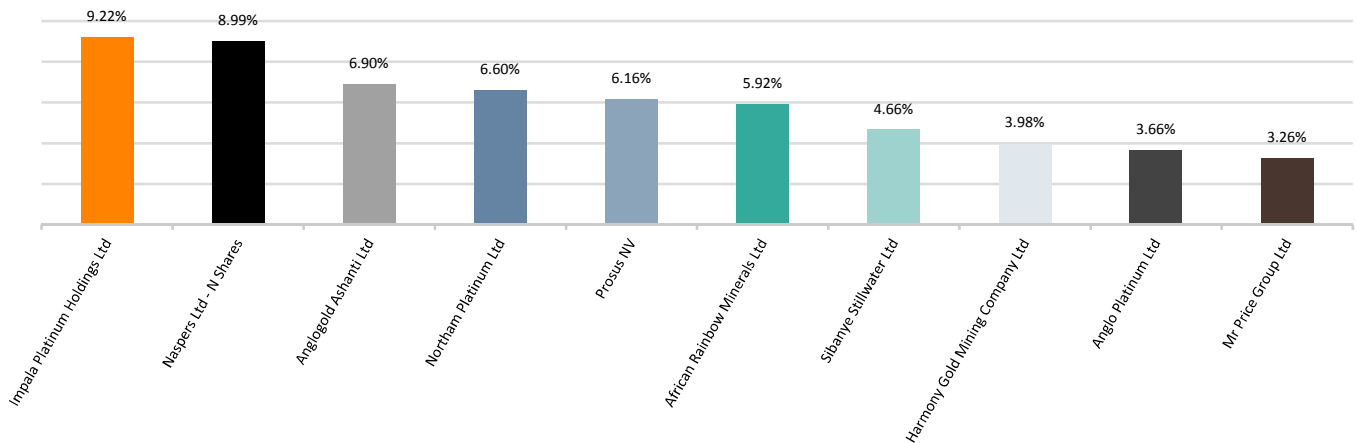

## MARKET COMMENTARY

The FTSE/JSE All Share Index (ALSI) increased by 7.7% during June. FTSE/JSE Shareholder Weighted Index (SWIX) increased by 8.1% and FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX) increased by 7.0%. The Rand strengthened by 1.1% during the month. Resources, Industrials and Financials increased by 8.8%, 8.3% and 4.2% respectively.

During June, Bonds decreased by 1.2% and Cash returned 0.5%. The MSCI Emerging Market Index increased by 7.4% (USD), outperforming the MSCI World Index which increased by 2.6% (USD). The MSCI South Africa Index increased by 10.4% (USD).

During June Iron Ore fines increased by 5.8% to \$100.1/t and Thermal Coal decreased by 6.4% to \$55.4/t. Brent Crude oil increased by 8.1%, ending the month on \$41.3/bbl. Gold was up 2.9% to \$1781/oz and Platinum decreased by 1.0% to \$829.4/oz. Palladium increased by 0.2% to \$1943.7/oz.

Given China's economic restart and significant stimulus, we have seen steel production increase to levels above last year supporting demand for iron ore while continued supply weakness from Brazil and capacity constraints in Australia have curtailed the likelihood of iron ore supply growth. We expect the iron ore price to be further supported by additional demand recovery from the world ex-China as soon as steel production recovers to normal levels of output. The rest of China's rebound will support the entire resource sector and we are of the view that metal prices will remain robust for the remainder of the year. We increased our gold position into the equity market sell off in March and believe the gold price will remain supportive given deep negative real rates and potential for dollar weakness. Our gold position has been a significant contributor to performance and we continue to hold an overweight in Gold.

We are cautious to position into SA Inc. too early and as much as we have increased our overall position, we remain underweight the sector. That said, some stocks screen attractively from a valuation perspective. With lower interest rates and lower oil prices, plus pockets of the economy having opened up, we believe the SA retail sector, most notably credit retail, as well as some defensive financial counters offer great opportunities.

The VIX Index (Volatility or 'Fear' Index) increased by 10.6% to 30.4 during June.

The fund's performance was positively affected by positions in AngloGold (19.1%), Naspers (13.4%), Harmony (25.2%) and Prosus (12.9%), while Bidvest (-6.5%), FirstRand (-5.2%), Impala (-0.9%) and Kumba (-2.4%) detracted from performance.

The fund invests in a number of focussed strategies. Amongst these strategies we are overweight Earnings Growth (Rand Hedge Consumer Discretionary), Cyclical (Diversified Mining, Platinum), Defensive (Gold Mining) and Value (Property, Local Consumer Discretionary).

## GLOSSARY

**Annualised Performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

**Transaction Costs (TIC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

## SPECIFIC RISK

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

The Portfolio is more diversified than the benchmark, thus holding smaller positions in the largest capitalisation stocks than the benchmark. This comes with the risk of more volatile relative returns to the broader market when the largest stocks in the benchmark outperform. We believe however that this strategy of holding a more diversified portfolio results in lower single stock risk, and whilst there may be periods of underperformance when the large cap stocks rally, we firmly believe in efficient risk management on an absolute basis. The strategy is also exposed to various factors driving investment performance, for example Value and Momentum, and these factors may also experience periods of relative underperformance. Global research has shown however, that consistent long term exposure to these factors lead to investment reward. This portfolio is permitted to invest in foreign securities which may have additional risks (FX Movements for example). However, the portfolio does not currently hold any foreign securities and the manager does not intend on exposing the portfolio to any foreign securities going forward.
