### INVESTMENT OBJECTIVE

The Fairtree Global Flexible Income Plus Fund has as its primary objective the generation of a high level of current income, which will be achieved primarily through investment in debt and debt-related securities. 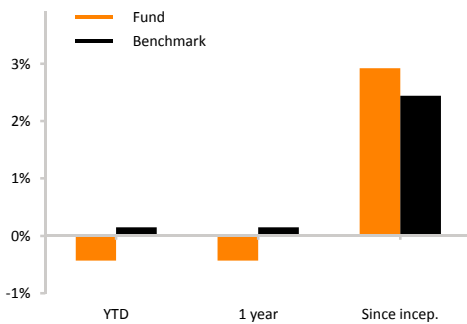
### RISK INDICATOR DEFINITION

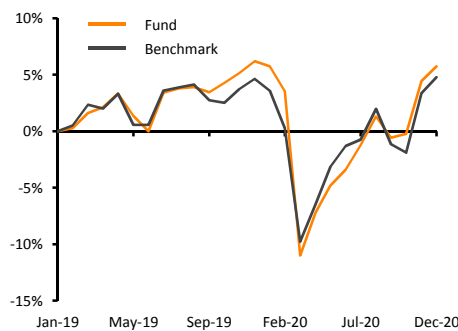
### RISK INDICATOR

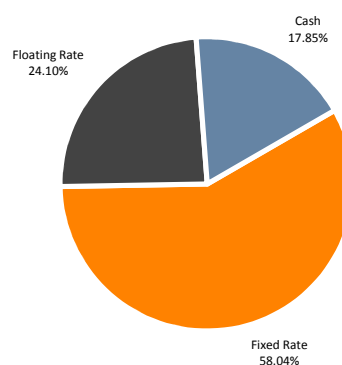

## MARKET COMMENTARY

During December our benchmark credit risk appetite index, the iTraxx Crossover 5 year spread index rallied some 24 basis points (bps) to end the month at 241 bps or only some 36 bps higher than where it started 2020. The total return index produced some 1.38% and puts the index into the green for the entire year, having produced 0.15%. All in all risky assets have performed well since the end of March and the iTraxx Crossover Total Return Index has delivered some 16.16% since the end of Q1.

Global defaults remain elevated with some 20 credit default auctions taking place during 2020, significantly higher than the 12 experienced the previous calendar year.

In performance terms, the fund produced some 1.24% over the month, marginally underperforming the index but the managers feel comfortable with the present positioning of the portfolio. As we have stated the fund is currently running a barbell strategy which, given the high cash component, leaves the fund in a strong position to buy any dislocated assets when they arise.

## GLOSSARY

**Annualised Performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

**Transaction Costs (TIC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

## SPECIFIC RISK
