### INVESTMENT OBJECTIVE

The Fairtree Global Flexible Income Plus Fund has as its primary objective the generation of a high level of current income, which will be achieved primarily through investment in debt and debt-related securities. The Fund may also invest from time to time in global currencies, equities and equity-related securities and collective investment schemes.

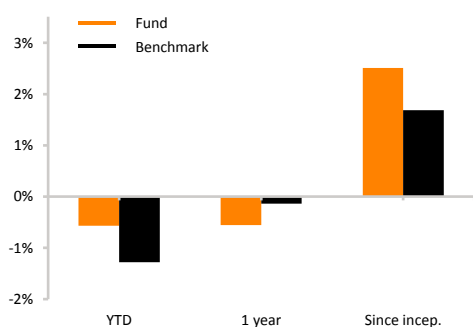
### RISK INDICATOR DEFINITION

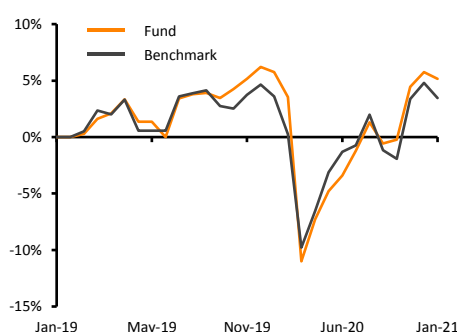
### RISK INDICATOR

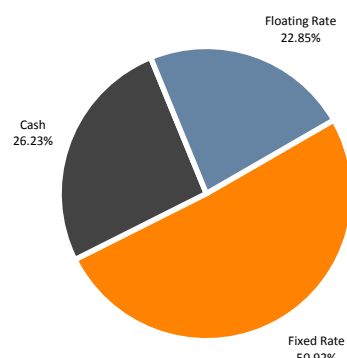

## MARKET COMMENTARY

Our basic global risk appetite coincident indicator, the iTraxx Crossover 5 year spread faltered during the month, selling off from 241 basis points (bps) to end the month some 28 bps higher at 269 bps. This was largely driven by the broader theme in development market risk, where most indices were lower during the period. The iTraxx on-the-run 5 year Total Return index did come off the boil somewhat, losing some 1.28% and basically giving back the gains of the previous month. For our much preferred levered index (ITRXTX25) it was a rather disappointing -2.53% month. We do like this index as it is a direct comparative in risk terms to equity, allowing for better debate about the pros and cons of the asset class.

There were no notable defaults reported by Markit during the month, although the Recovery Auction for Europcar Mobility Group was conducted on the 13th of the month. A final recovery price of 100% was registered, so no losses for credit default swap protection sellers on that name. The auction result was somewhat better than expected as the underlying bonds were trading at 73% of face value prior to the auction.

The fund delivered a loss of 0.57% during the month which compares favourably with the underlying benchmark which lost some 1.28%.

## GLOSSARY

**Annualised Performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

**Transaction Costs (TIC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
